

GTC Freestyle Academy Laax incl. Gym and Training Center FSA

Special Terms and Conditions of the Weissen Arena Gruppe BGB WAG

1. Scope of Application

These GTC's apply to the use of the Freestyle Academy hall, the Freestyle Academy Laax gym and the Freestyle Academy Laax training center.

In addition to the [WAG General Terms and Conditions](#), you accept the "Freestyle Academy LAAX Terms and Conditions" (hereinafter "FSA GTCs") with every booking of an offer from Freestyle Academy LAAX. Any deviations from the "FSA GTCs" or your own terms and conditions shall only apply if expressly agreed in writing or electronically.

2. Contracting Party

You acknowledge and accept that your contract is concluded with Mountain Adventures AG (hereinafter "MAD"), regardless of which company within the WAG pool accepts and/or executes your order.

3. Conclusion of Contract

The contract is concluded by either (a) written or electronic confirmation of the agreed services in conjunction with an advance payment, or (b) a verbal agreement made on site with immediate payment. By entering into the contract, you accept the service/product descriptions, prices, and payment terms applicable at the time the contract is concluded. The services, prices, and conditions stated on websites, in brochures, or in other publications are provided for informational purposes only and may be subject to change until the contract is concluded.

4. Amendments

MAD reserves the right to make changes to the program or services offered after the contract has been concluded if such changes become necessary for any reason whatsoever. Such changes shall not give rise to any right to withdraw from the contract or to claim damages, provided that the nature of the contractually agreed service is not materially altered.

If you register multiple persons for a service, you shall be responsible for ensuring that all registered persons comply with the contractual obligations, including, in particular, payment for the services.

5. Liability

MAD warrants that instruction and training will be provided in a proper and professional manner and that all services will be rendered in accordance with the contract. Use of the facility is at the user's own risk. The operator shall be liable only for damages caused by gross negligence or wilful misconduct. Users are responsible for assessing their own state of health and, in cases of uncertainty, for seeking medical advice.

In all other respects, Section 8 of the [WAG General Terms and Conditions](#) shall apply.

6. House rule

Instructions issued by staff must be followed at all times. Equipment must be used with due care and left in a clean and orderly condition after use. Gym slippers, anti-slip socks, or trampoline socks are mandatory in the trampoline area. Any damage to or defects in equipment must be reported immediately.

7. Freestyle Academy Hall

7.1. Changes or Cancellation of Admission or Courses at the Indoor Facility

If you change or cancel reservations or bookings for admissions or courses, and unless otherwise stated in the confirmation, MAD will charge the following cancellation fees:

Cancellation period before the service	Cancellation fee as % of total price
Up to 21 days	Free of charge
20 to 7 days	25%
6 days to 24 hours	50%
Less than 24 hours	100%

The relevant date and time for the calculation is the receipt of your notification by MAD.

7.2. Loss of Subscription

In the event of loss of an annual or seasonal subscription, it may be renewed for the remaining subscription period for an administrative fee of CHF 10.00 (including wristband).

8. Gym Freestyle Academy

8.1 Opening hours & access and use

The gym is open daily from 6.00 a.m – 10.00 p.m opening hours are subject to change without prior notice. Access is granted either by means of a single-entry pass or a six-month membership. The six-month membership is valid for six (6) months from the date of purchase. The maximum occupancy of the room is limited to 8 persons at any one time.

8.2 Subscriptions and admissions

Single-entry passes and memberships are personal and non-transferable. As a general rule, no refunds or extensions will be granted, including in cases of non-use.

8.3 House rule

Instructions issued by staff must be followed at all times. Equipment must be used with due care and left in a clean and orderly condition after use. For hygiene reasons, the use of a towel is mandatory. Clean athletic shoes must be worn at all times. Any damage to or defects in equipment must be reported immediately. Users are expected to behave in a respectful and considerate manner towards others at all times while using the

8.4 Haftung

Use of the gym is at the user's own risk. The operator shall be liable only for damages caused by gross negligence or wilful misconduct. No liability is accepted for the theft, loss, or damage of personal belongings. Users are responsible for assessing their own state of health and, in cases of uncertainty, for seeking medical advice

9. Recreational Sports and Training Center

9.1. Changes or Cancellation

If you change or cancel reservations or bookings for subscriptions, training sessions, camps, or contests, and unless otherwise stated in the confirmation, MAD will charge the following costs:

Cancellation period before the service	Cancellation fee as % of total price
Training	Min. 90%
Camps	100%*
Contests	100%*
Subscriptions	100%

*In the event of a call-up by Swiss-Ski resulting in the cancellation of a camp or contest, the fees will be waived.

We recommend taking out cancellation insurance, which may cover cancellation costs

9.2. Indoor Training Subscription (Recreational Sports and Training Center)

Anyone booking off-snow training at Freestyle Academy is required to purchase an "Indoor Training Subscription" The subscription is valid for one training year.

9.3. Gym Training Subscription (Training Center)

Anyone booking coordination or conditioning training at Freestyle Academy is required to purchase a "Gym Training Subscription" The subscription is valid for one training year.

9.4. Lift Ticket (Recreational Sports and Training Center)

The lift ticket can be booked through the FSA at a preferential price in combination with snow training.

10. FSA Club (Training Center)

A Membership at the Freestyle Academy Club is automatically required for every participant as well as one parent.

MAD may refuse or discontinue services at any time without compensation if there is justified cause to do so. The same applies if, within the framework of a contractual agreement, only certain individual services are intentionally used instead of the full service package, if instructions from MAD staff are disregarded, or if access authorizations are misused. MAD reserves the right to impose a ban from the premises.

Applicable Law and Place of Jurisdiction

This contract is governed by Swiss law. The venue of jurisdiction is the municipality of Laax.
